**DPW Facility Site Grading  
PROJECT # 2018-03**

**OWNER/ TIME:** The City of Cudahy is soliciting bids for the grading and the construction of storm water facilities at its proposed Public Works Facility site located at 5133 S. Whitnall Ave. Sealed bids will be received by the City of Cudahy, Milwaukee County, Wisconsin, until **Friday, June 22, 2018 @ 10:00 a.m.** at the City of Cudahy, City Hall, 5050 S. Lake Drive, P. O. Box 100510, Cudahy, Wisconsin 53110. Bid proposals will be publicly opened and read aloud at the above time and place. Each bid proposal must be submitted on the bid/proposal form provided in

the Contract Documents and shall be enclosed in a sealed envelope addressed to the City of Cudahy and marked "Bid" with the project name.

The project consists of grading 3.5 acres of an 8.5 acre site in the City of Cudahy for a proposed salt storage facility. The grading will require the removal of 12" of material on site and the crushing and placement of 12" of recycled asphalt millings (city supplied). The work also includes the grading and installation of a storm water "rain garden", bio-swale and shallow storm water system. **Work can be scheduled between August 1, 2018 to July 1, 2019.**

Lake Dr.) or digitally through the City "Dropbox" by calling (414) 769-2212 starting Friday, June 8, 2018 between the hours of 7:30 a.m. to 4:30 p.m. The Contract Documents are free. All bidders shall bid in accordance with and shall bid upon the forms provided.

**STATUTORY PROVISIONS:**

The contract letting shall be subject to the provisions of the Wisconsin Statutes, including Section 62.15, 66.0901, 66.0903, 779.14 through 779.16.

**BID GUARANTEE:** No bid will be received unless a certified check or bank draft payable to the City of Cudahy, or a satisfactory bid bond in an amount no less than five percent (5%) of the bid, shall accompany each bid as a guarantee that if the bid is accepted, the bidder will execute and file the Agreement and a 100% performance bond and payment bond, within ten (10) days after the Notice of Award. In case the bidder fails to file such contract and bond within the time set forth,

the check or bid bond shall be forfeited to the City of Cudahy as liquidated damages.

**BID WITHDRAWAL:** No bid shall be withdrawn for a period of ninety (90) days after the bid opening date without the consent of the City of Cudahy.

**BID REJECTION:** The City of Cudahy reserves the right to accept any bid most advantageous to the City, waive any technicality or reject any or all bids. Bidder will be required to submit prequalification prior to the award date. Review and acceptance of prequalification will be made by the City as part of the award.
